ORCIDs enable accurate attribution and improved discoverability of an author's published work. The author will need a registered ORCID in order to submit a manuscript or review a proof in this journal.

- 1. Login to ScholarOne and click on your name in the top right corner of the screen.
- 2. Click E-mail / Name in the dropdown menu.
- 3. In the ORCID section at the top of the page, click the appropriate link to either register for a new ORCID or associate the account with an existing ORCID.
- 4. A new page will open to create and/or validate your ORCID. Once the validation is complete, the new page will close and you will return to ScholarOne.
- 5. Save the changes to your ScholarOne user account.

These FAQs are intended to help societies, editors, and peer review support specialists answer questions about the ORCID implementation.

What is ORCID?

Open Researcher and Contributor ID (ORCID) is a not-for-profit organization that provides persistent unique identifiers for researchers, much like a DOI does for a published article. Researchers can sign up for an ORCID for free via an easy registration process on <u>orcid.org</u> or via ScholarOne or the Author Gateway. Do co-authors need ORCIDs?

ORCIDs for co-authors are encouraged. Corresponding authors can ask their co-authors to link their ScholarOne accounts to their ORCIDs.

How is the ORCID collected?

Both ScholarOne and the Author Gateway collect ORCIDs via a link out to orcid.org. The user is returned to their previous screen after the ORCID is collected and verified. ORCIDs cannot be entered manually; this ensures that the ORCID is valid.

Why is IEEE implementing this policy?

ORCID disambiguates author names, allowing for accurate attribution and improved discoverability.

Do any other publishers have this policy?

IEEE joins 16 other major journal publishers in requiring an ORCID for submission. An additional 40+ publishers request but do not require ORCIDs during submission. You can read more at https://orcid.org/content/requiring-orcid-publication-workflows-open-letter.

Does the author need to add their ORCID to every manuscript they submit?

The author needs to add their ORCID only once per ScholarOne site. If the author has an account on another journal's ScholarOne site, then the author will follow the same process for that journal.

ORCID is a registry of unique identifiers for researchers and scholars that is open, non-proprietary, transparent, mobile, and community-based. ORCID provides a persistent digital identifier that distinguishes you from every other contributor and supports automated linkages among all your professional activities.

ORCID is about disambiguating your research from others' with the same or similar names. Without disambiguation, we will continue to manually weed our bibliographies. We have better things to do with our time.

ORCID is founded on interoperability with multiple systems and institutions. ORCID allows you to link with other identifier systems, including those maintained by funders and publishers, and exchange data freely with those research information systems.

Registration is free and fast for all researchers and scholars.

ORCID, an independent, not-for-profit organization designed to benefit all stake-holders, is unique in its ability to reach across disciplines, research sectors, and national boundaries. The ability to connect research and researchers enhances the scientific discovery process and improves the efficiency of research funding and collaboration. ORCID is engaging with all sectors of the research community to realize this vision.
